Rotary is a global network of 1.4 million neighbors, friends, leaders, and problem-solvers.


We provide service to others, promote integrity, and advance world understanding, goodwill, and peace through our fellowship of business, professional, and community leaders.

#### Rotary Organization


"Rotary" is made of these main levels:

- Clubs (organized within District and Zone levels)
- Rotary International
- The Rotary Foundation

Together, we work to make lasting change in our communities and around the world.



Our district is in Rotary Zone 25B & 29



The Rotary world is divided into 34 zones, each with approximately the same number of Rotarians. Zones are paired together, and each pair of Zones, elects a director to serve a two-year term on the Rotary International Board of Directors, for a total of 17 directors.

#### Our Club History

- The Madison West Rotary Club was chartered in 1957
- The Rotary Club of Madison West-Towne Middleton was chartered in 1971 and was sponsored by the Madison West Rotary Club.
- On 1 July 2022, the Madison West and Madison West-Towne Middleton Rotary clubs merged.
- The club is now known as THE ROTARY CLUB OF MADISON WEST MIDDLETON
- The two foundations also merged, becoming the ROTARY MADISON WEST MIDDLETON FOUNDATION



Madison West Middleton Rotary Foundation, Inc., was formed to allow donations that support community fundraising efforts of the Rotary Club of Madison West Middleton to be tax deductible by individual donors.

 Madison West Middleton Rotary Foundation, Inc. – managed by a Board of Directors under the advisement of an Investment Committee (meets quarterly) who are members of the Madison West Middleton Rotary Club (assets ~ \$300,000)



- <u>Incorporated</u>: in 1975 under IRS Revenue Code Section
   501(c)(3) not for profit corporation
- Purpose: To undertake, promote, develop and continue charitable giving in the realms of community, vocational and international service projects by making distributions, awards and gifts for such purposes; to receive gifts of cash, securities and other property and to hold, invest or sell such gifts to fulfill the purposes of the Corporation.



- **Members**: The members of this Corporation are also the same as the Members of the Rotary Club of Madison West Middleton
- **Board of Directors:** The currently serving Board of Directors of the Rotary Club of Madison West Middleton serves also as the BOD of the Foundation
- Officers and Directors follow same service terms as they hold within the Rotary Club.
- An appointed investment committee, comprised of Rotary Club Members with investment expertise, meet at least quarterly and serve both as advisors and conduct the business of the Foundation. The Treasurer serves as chair of this committee.



Two major funds within the Foundation:



- Endowment Fund (undesignated funds)
- Legacy Fund (Designated funds)

## **Endowment Fund**(Undesignated Contributions)

The purpose and function of the Endowment Fund shall be to accumulate funds which are undesignated with respect to purpose or function, meaning that such funds may be used for any purpose or function permitted by the guidelines of the Corporation's policies. The earnings shall be accumulated without regard to any allocation among donors. The corporation may spend from the Endowment Fund in any fiscal year an amount not to exceed five-percent (5.0%) of the average total undesignated amount in the Legacy Fund at the end of each of the twelve calendar quarters ending on the March 31st immediately preceding that fiscal year.



## Legacy Fund (Designated Contributions)



The corporation may accept and administer contributions which specifically designate each donor's instructions with respect to his/her specific purpose and intent. The earnings of each donor's contribution shall be allocated to the door's contributions, if those were the donor's instructions.



I joined Rotary because I have always felt that service to the community is the right thing to do.





#### **ROTARY INTERNATIONAL**

Governed by a RI president, elected to a one-year term, and a Board of Directors elected by the clubs every year at the Rotary International Convention. Each director serves for two years and represents two of the 34 Rotary zones.

The mission is to provide service to others, promote integrity, and advance world understanding, goodwill, and peace through its fellowship of business, professional, and community leaders.

#### **ROTARY FOUNDATION**

Organized as a public charity operated exclusively for charitable purposes and governed by a *Board of Trustees* appointed to 4-year terms by RI president-elect and Board of Directors.

The mission is to enable Rotarians to advance world understanding, goodwill, and peace through the improvement of health, the support of education, and the alleviation of poverty.



## **Foundation history**




At the 1917 convention, outgoing Rotary president Arch Klumph proposed setting up an endowment "for the purpose of doing good in the world." That one idea, and an initial contribution of \$26.50, set in motion a powerful force that has transformed millions of lives around the globe.

Since it was founded more than 100 years ago, the Foundation has spent more than \$4 billion on life-changing, sustainable projects.
